Forecasting should not be treated as a black-box approach, but as a professional process managed by knowledgeable executives. To provide reliable forecasts you must know about the nature of forecasts, the origin and value of historic (sales) data, the best way in which to calculate accuracies and how to use this information in the forecasting process. Managers don't need to know in depth how all the formulae work, but they must be able to value and weigh the outcomes. In this Master Class we will do exactly this. We will show you how to set up an efficient and effective forecasting process. We will also identify which key-staff must be involved. Finally, you will learn how to make sure you get the right data, how to organize this data and how to improve the sales forecast by use of smart performance indicators and feedback processes.
